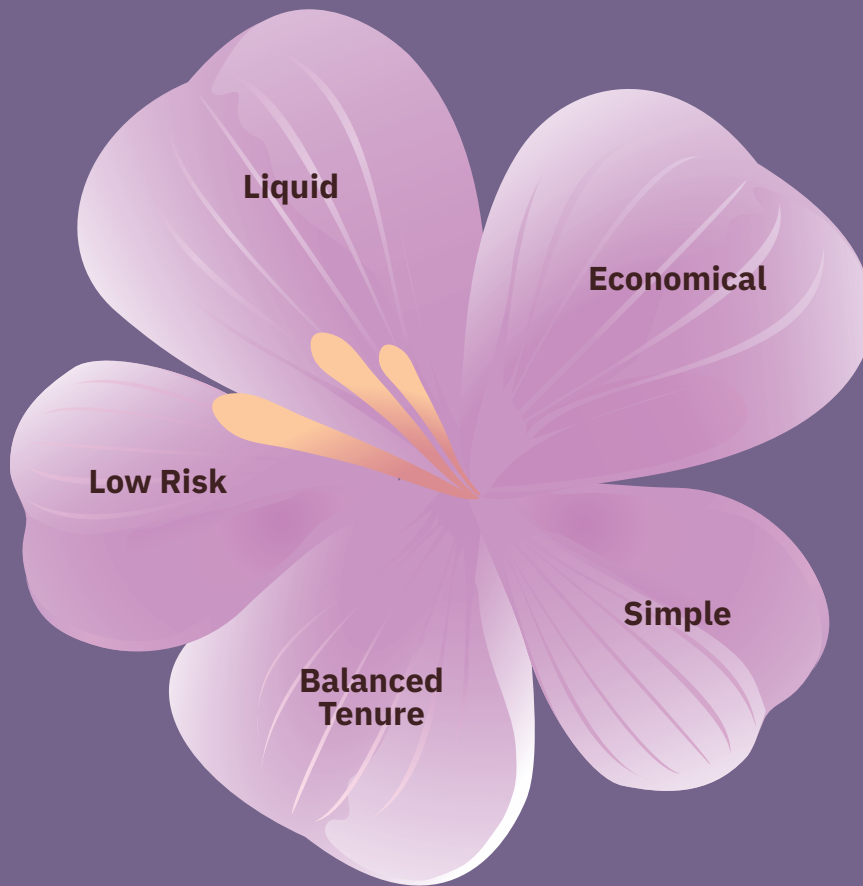

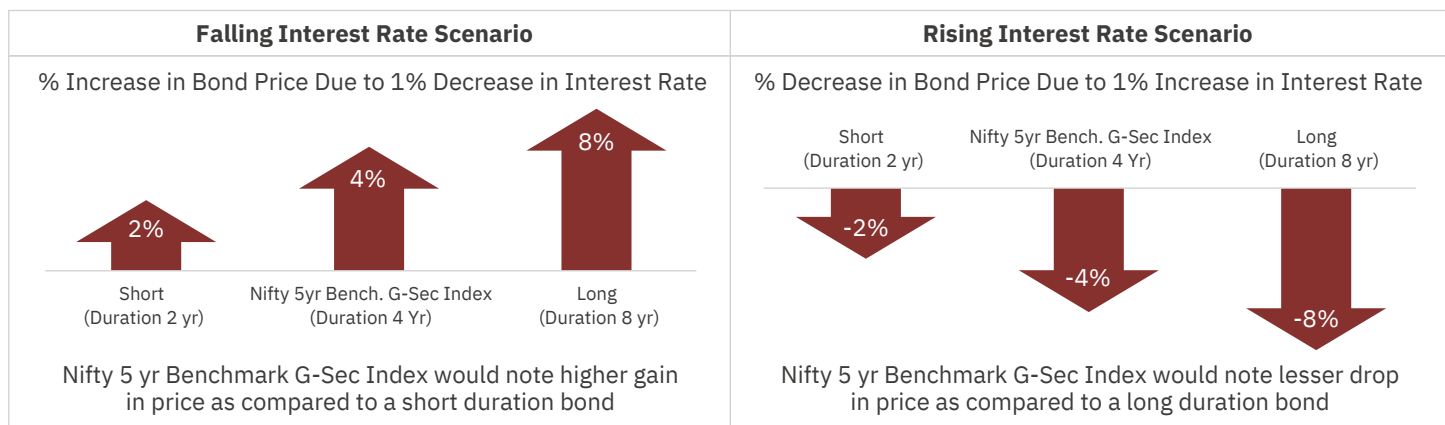
About Nifty 5 yr Benchmark G-Sec Index
