The BSE Low Volatility Index is designed to track the performance of the 30 companies in the BSE LargeMidCap with the lowest volatilities, as measured by standard deviation.

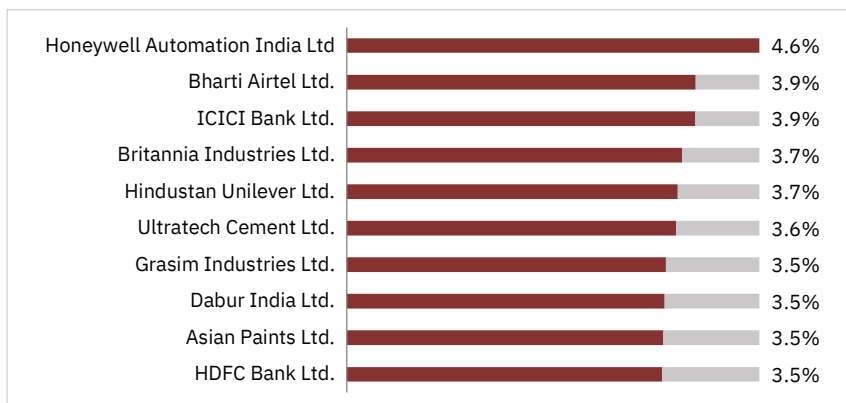
